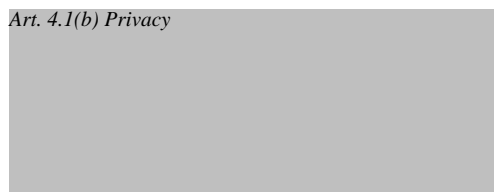
After this deadline, the participants will receive an email invitation with all **technical details** for the connection by videoconference.
