Your question has been transmitted to me and I can confirm that in line with the latest amendment to Regulation 809/2014, Member States have full subsidiarity in setting the deadline for lodging the single application. Hence, they are free to choose a date without the Commission approval.

Under the link below, you will find the amending regulation published in the Official Journal and applicable as from claim year 2021.
The relevant change refers to Article 13(1).

Dear Art. 4.1(b) Privacy,

I don't know if you can help me but I have a question regarding the date for aid application.

Regulation 809/2014 establishes in its art.13 that the final date for submission of aid application is 15th May (except for Estonia, Latvia, Lithuania, Finland and Sweden in which case they have 1 extra month).

Now:

- a) Is this still valid? Or has this regulation been changed?
- b) Any derogation to this must be "authorized" by the EC?

Can you clarify this? I was told that this regulation 809/2014 had been changed and that MS did not need anymore the Commission's authorization for changing the final date of submission of aid applications.
