Attached, you will find a presentation of our company. I would be grateful if you could forward it to Mr Beltramello.

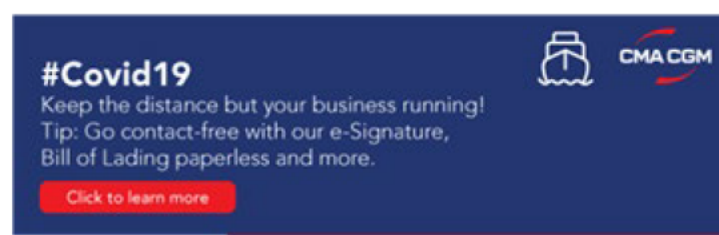
