Dear VERHEECKE Lora,

We refer to your application for access to documents in object submitted within the framework of Regulation (EC) No 1049/2001.¹

1. SCOPE OF YOUR APPLICATION

In your application GESTDEM 2022/0098, registered 08/01/2022, you requested access to:

• All documentation (including but not limited to all email correspondence, attendance lists, agendas, background papers, transcripts, recordings and minutes/notes) relating to the meeting between Thierry Breton and ASD on 10th November 2021.

We have identified the following documents as falling within the scope of your request:

After having consulted ASD and LEONARDO regarding the documents and information originating from them in accordance with Articles 4(4) and 4(5) of Regulation 1049/2001, DG DEFIS:

- gives partial access to Document 1-6 only subject to the redaction of personal data on the basis of Article 4(1)(b) (protection of the privacy and the integrity of the individual);
- gives full access to Document 7.

Please see below our analysis on the requested documents.

2. ASSESSMENT AND CONCLUSIONS UNDER REGULATION 1049/2001

2.1. Protection of privacy and the integrity of the individual

According to Article 4(1)(b) of Regulation (EC) 1049/2001, access to documents is refused where disclosure would undermine the protection of "privacy and the integrity of the individual", in particular in accordance with European Union legislation regarding the protection of personal data².

The requested Documents 1-6 contains personal data such as names, functions and contacts of Commission's officials not having the function of senior management staff and of third parties identified in the documents. This information clearly constitutes personal data in the meaning of Article 3(1) of Regulation 2018/1725.

Pursuant to Article 9(1)(b) of Regulation 2018/1725, personal data shall only be transmitted to recipients established in the Union other than Union institutions and bodies if '[t]he recipient establishes that it is necessary to have the data transmitted for a specific purpose in the public interest and the controller, where there is any reason to assume that the data subject's legitimate interests might be prejudiced, establishes that it is proportionate to transmit the personal data for that specific purpose after having demonstrably weighed the various competing interests'.

According to Article 9(1)(b) of Regulation 2018/1725, the European Commission has to examine the further conditions for a lawful processing of personal data only if the first condition is fulfilled, namely if the recipient has established that it is necessary to have the data transmitted for a specific purpose in the public interest. In your request, you do not put

forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Therefore, personal data have been redacted in the requested documents.
