**upcoming revision of CO2 emission
standards for trucks**, with you. Given your
respective Cabinet responsibilities on these
issues, they would be very grateful for a joint
meeting with both of you, if possible.

As you may know, Gasum is a major Nordic

the green transition in transport and industry.
Operating in Finland, Norway, Sweden, and

Germany, it is the leading enterprise in the supply of biogas and distribution of liquefied natural gas (LNG) in the Nordic countries.
