Dear Madam, Dear Sirs,

Bruno Le Maire, French Minister of the Economy and Finance, has entrusted [REDACTED] Amundi and [REDACTED] with the mission to coordinate the French financial sector in their alignment with the Paris Agreement. This mission follows the Minister's speech at the Paris Climate Finance Day on 26 October 2021, during which he encouraged all financial players in the Paris marketplace to commit to a pathway out of coal and non-conventional oil financing, in line with the Paris Agreement, and beyond that to commit to a trajectory towards reducing the carbon intensity of portfolios and companies. The Minister would like this trajectory to be objective, measurable and transparent, accompanied by a gradual and binding timetable.

As part of his mission, [REDACTED] [REDACTED] would be honored to exchange with Commissioner McGuinness to benefit from her strong experience and her analysis of the subject.

The report being due by the end of February 2022, would Commissioner McGuinness be available for a one-hour meeting with [REDACTED]? We could for example suggest January 4th at 4pm; January 17th at 9am; January 18th between 9am and 12pm; January 24th between 10_30am and 12_30pm; January 26th at 9am; January 27th between 10am and 12pm, but we would of course do our utmost to adapt to the Commissioner's agenda.
