The number of official controls performed in all fields of animal welfare legislation for 2020 has decreased due to the COVID-19 pandemic which hindered physical on site inspections. Isolation measures as well as extremely high number of incidents of COVID -19 in workers which are still continuing has contributed to these results. In general terms, the levels of compliance are similar to those of previous years.

Θα πρέπει να σημειωθεί ότι παρατηρείται υστέρηση ορισμένων περιφερειακών υπηρεσιών που είναι επιφορτισμένες με τη διεξαγωγή επίσημων ελέγχων για την προστασία των ζώων κατά τη μεταφορά, κατά τη θανάτωση και στις εκτροφές. Οι αιτίες αυτής της υστέρησης οφείλονται κατά κύριο λόγο στη διαρκή μείωση του κτηνιατρικού προσωπικού στις εν λόγω υπηρεσίες, τη διεξαγωγή επίσημων ελέγχων κατά προτεραιότητα για τον τομέα της υγείας των ζώων και της κτηνιατρικής δημόσιας υγείας και τη σημαντική μείωση των επιτρεπόμενων ημερών για εκτός έδρας μετακινήσεις καθώς και των διαθέσιμων οικονομικών πόρων. Τέλος, όπως αναφέρθηκε και παραπάνω, η πανδημία COVID-19 έβγαλε εντελώς εκτός προγραμματισμού τη διαδικασία οργάνωσης των επίσημων ελέγχων σε όλες τις υπηρεσίες της Επικράτειας.
