Dear Colleagues,

I am reaching out on behalf of the U.S. Chamber of Commerce's European Affairs Program. **We are bringing a delegation of senior business leaders to Brussels for our first in-person delegation since early 2020 between the morning of Tuesday, May 17 and mid-day Thursday, May 19.** The delegation will be led by [REDACTED] and [myself](#).

While in Brussels, **we'd be delighted to meet with EVP Dombrovskis at a time that is convenient for your schedule.** We greatly enjoyed the discussion with the EVP when he was in Washington recently, and we want to take him up on his offer to meet again in Brussels following the conclusions of next month's TTC ministerial.

Beyond the TTC itself, we are interested in discussing a range of other timely topics including: transatlantic coordination in the face of the Russia-Ukraine crisis, partnership on shared challenges from China and other non-market economies, digital trade, energy policy and addressing the climate crisis, and other shared policy priorities. Of course, we would also be glad to share our perspective on the latest developments on this side of the Atlantic.

We will have approximately 12-15 senior executives (predominately based in Washington) joining the trip from firms including: Apple, Cigna, Google, IBM, Lilly, MetLife, PhRMA, Sempra, Shopify, Viartis, Walmart, and Zimmer Biomet. Their titles range from Head of Global Trade Policy to Head of International Government Relations to VP of Global Government Affairs (and similar).

I look forward to hearing from you and would be happy to answer any questions you might have about our upcoming visit. I hope we can find time to meet again in person soon.
