**Subject:** Your application for access to documents – GESTDEM 2022/2850

Dear Mr Fanta.

We refer to your email of 18 May 2022 in which you make a request for access to documents, registered on 19 May 2022 under the above-mentioned reference number.

You request access to:

- All documents relating to a meeting between Commissioner Ylva Johansson, Cabinet members and TikTok on 26/10/2021. This includes meeting minutes, emails and any other communication related to said meeting;
- Other documents related to TikTok or originating from exchanges (e-mails, etc.) with TikTok since November 1, 2019.

A list of the identified documents is included in the Annex.

Parts of the documents relate to information that does not concern TikTok and therefore is not concerned by your request. This information is therefore out of scope of the request and has been redacted.

Having examined documents requested under the provisions of Regulation (EC) No 1049/2001 of the European Parliament and of the Council of 30 May 2001 regarding public access to European Parliament, Council and Commission documents, I have come to the conclusion that these documents may be disclosed.

However, a complete disclosure of the identified documents is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation 1049/2001, because some of them contain the following personal data:

- the names/initials and contact information of Commission staff members not pertaining to the senior management;
- the names/initials and contact details of other natural persons;
- other information relating to an identified or identifiable natural person, such as positions held in an organisation.

Article 9(1)(b) of the Data Protection Regulation<sup>1</sup> does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor put forward arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation 1049/2001, access cannot be granted to the personal data contained in the requested documents, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

Regarding the disclosed minutes and summary records of meetings, the documents were drawn up for internal use under the responsibility of the relevant services of the Directorate-General for Home Affairs and Migration. They solely reflects the author's interpretation of the interventions made and do not set out any official position of the third parties to which the documents refer, which was not consulted on its content. They do not reflect the position of the Commission and cannot be quoted as such.

In case you would disagree with this position, you are entitled, in accordance with Article 7(2) of Regulation 1049/2001, to submit a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretariat-General of the Commission at the following address:
