Dear Ms Roxburgh,

We refer to your e-mail of 29 July 2022, registered on 2 August 2022, in which you make a request for access to documents under the above-mentioned reference number, and to your e-mail of 4 August 2022 clarifying your request.

You request access to:

“All documentation (including but not limited to all email correspondence, attendance lists, agendas, background papers, transcripts, recordings and minutes/notes) relating to the meeting listed below:

- 1. Between ArcelorMittal and Gints Freimanis, Cabinet member of Valdis Dombrovskis on the 4th February 2022*
- 2. Between ArcelorMittal and Joan Canton, Cabinet member of Thierry Breton on the 20th October 2021*
- 3. Between ArcelorMittal and Kurt Vandenbergh, Cabinet member of Ursula von der Leyen on the 19th October 2021”.*

With the following clarification: *“I am specifically looking for bilateral meetings between the Cabinet and the targeted stakeholders mentioned in the request”.*

Please note that due to the wide scope of your request, covering also areas falling under the responsibility of other Directorates-General, parts of your request have been attributed to other Directorates-General¹ for the points that do not concern the Cabinet of Commissioner Thierry Breton. This reply relates only to the documents held by the Directorate-General for Internal Market, Industry, Entrepreneurship and SMEs (DG

GROW). You received /will receive the replies from the other respective Directorates-General in due course.

We have identified the enclosed email that fall within the scope of your request. Please note that the annex to this email was a report that is directly available online here: <https://corporate.arcelormittal.com/sustainability/climate-action-reports>.

A complete disclosure of the identified document is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because it contains the following data:

- the names/initials, functions and contact information of Commission staff members not pertaining to the senior management;
- the names/initials, functions and contact details of other natural persons.

Article 9(1)(b) of the Data Protection Regulation does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested document, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

In case you would disagree with this position, you are entitled, in accordance with Article 7(2) of Regulation (EC) No 1049/2001, to submit a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretariat-General of the Commission at the following address:
