- 4. The parts of the tender evaluation committee report with the findings about the financial and economic standing of the first contractor

According to our legal department, I quote:

""As regards third-party documents, the institution shall consult the third party with a view to assessing whether an exception in paragraph 1 or 2 is applicable, unless it is clear that the document shall or shall not be disclosed", meaning that we most probably should consult the two companies involved. They have the possibility to refuse access to the documents or to only give partial access, due to commercial interests. "

Here the exceptions listed in the regulation:

"Exceptions

- 1. The institutions shall refuse access to a document where disclosure would undermine the protection of:
- (a) the public interest as regards:
- public security,
- defence and military matters,
- international relations,
- the financial, monetary or economic policy of the Community or a Member State;
- (b) privacy and the integrity of the individual, in particular in accordance with Community legislation regarding the protection of personal data.
- 2. The institutions shall refuse access to a document where disclosure would undermine the protection of:
- commercial interests of a natural or legal person, including intellectual property, court proceedings and legal advice, the purpose of inspections, investigations and audits, unless there is an overriding public interest in disclosure."

I would therefore like to know if SWORD would authorise Eurostat to give access to this information or to refuse us to give access due to commercial interest.
