I am writing you on behalf of Aurora, a joint venture set-up by a Galp and Northvolt to develop a sustainable lithium conversion facility in Portugal. This partnership is a once-in-a-generation opportunity to reposition Europe as a leader in an industry that will be vital to bringing down global CO2 emissions, in line with European and Portuguese climate-change priorities.
