It was good talking to you at the ACEA reception a few weeks back.

I am reaching out to you today in the context of the review of the CO2 targets for trucks. As you may know, there is an informal coalition of a dozen associations from the energy, engineering and mobility sectors, exchanging on and articulating a shared perspective on the CO2 standards discussion.

We aim to understand better the current thinking in DG CLIMA on the review, particularly the need for

technology diversity to cater for different use cases and the role of climate neutral fuels in hard to abate sectors. It is our understanding that options are being assessed in preparation of the legislation. We are keen on contributing to this work and would like to discuss with you any possible solutions.

Please let me know if an (e-)meeting with you and representatives of the coalition would be feasible on relatively short notice in the coming days.
