Please excuse the direct approach – I helped Open Europe organise and livetweet their TTIP event with the Commissioner in Brussels in December and was passed on your contact details.

I am currently putting together a small delegation of IoD members and representatives to go to Brussels to meet with officials in the Commission on a range of issues from employment law to trade, and TTIP is chief amongst our policy priorities at the Institute of Directors (please see below for some our recent press articles/coverage to give you an idea). One of the projects I am currently undertaking is to put together a case study of around 25 smaller businesses who currently export to the US or have considered doing so to give an anecdotal flavour to what SMEs in particular stand to gain from TTIP.

I would greatly appreciate the chance to have some of these members meet with Commission Malmstroem to talk about their experiences and concerns and am wondering if anytime in early to mid-February might suit.

Some of the points we would like to discuss are progress on TTIP, in particular on Customs/Trade Facilitation, SME policy (the potential SME chapter), financial services, labour mobility for professionals in sectors where temporary staff are needed to assist with installation etc (we will have someone in the delegation in engineering services for whom this is a major issue), public procurement and obviously the broader narrative surrounding TTIP.

As I may have mentioned, I will be attending the next round of negotiations later in the week in New York, where I will be presenting several case studies on behalf of the IoD in the

SME and stakeholder forums, as well as trying to better ascertain what some of US industry's offensive interests are across a number of sectors.

We will be publishing our own case study report shortly after the UK election (which is happening on 7<sup>th</sup> May).

Should time allow, we would also like to discuss other free trade/investment agreements — in particular with China- and the modernisation of trade defence instruments, which we have some concerns about.

Please excuse the direct approach. I was very interested by your contribution on a recent Bruegel debate regarding TTIP.

By way of introduction, I head up Europe and Trade policy for the Institute of Directors, the largest cross-sectoral group for business leaders in the UK (the overwhelming majority of whom are SMEs – please see more information about the IoD further below).

We have been campaigning very hard, and very publicly in support of TTIP — please also see below for some of our interventions in the media. We are also in the midst of finalising a case study report on the potential benefits of TTIP for SMEs. I have been very involved myself, giving a presentation at the stakeholders forum during the last Brussels negotiating round, and recently returned from a trip to Washington to talk to members of Congress and other stakeholder bodies there to get a sense of the mood around TTIP as well. I have also had several meetings with people from DG Trade to discuss our efforts, among them [Article 4.1(b)].
