- (2) to decide that Mr Almunia's envisaged activity as member of the Advisory board of the Centre for European Policy Studies is compatible with Article 245(2) of the TFEU on the condition that Mr Almunia abstains, during eighteen months after the end of his mandate, from lobbying activity with the Commission and its services on matters linked to his former portfolio, for this body;
- (3) to instruct the Secretary General to inform Mr Almunia about the present decision, yet drawing his attention to the conditions stipulated therein.
