

Dear Madam, Dear Sir, Dear Mrs Hoffmann,

re my child re have been in contact as you can see below last in 2011.

I was not happy with your support. And, as you can see his case got unfortunately screwed up.

Now I am contacting you, the legal department of the EU Commission, again.

Since 28th Dec 2011 there is a decision from Malta Family court about joint custody and 5days visitation right per month with nightly sleepovers to see my child.

This decision was registered in UK on 16th March 2012. The full document is attached. This document is valid in UK.

There were several hearing at UK courts between June 2012 and March 2013. In the last hearing London High court got to know about the decision from Maltese Family court that UK will not get jurisdiction over the case. They have to implement the in UK registered order.

At the hearing on 21. March 2013 the Judge Mr Mostyn again pushed to get the Jurisdiction. I said 'no'. Also I did not accept that my child is immediately returned to Malta (as this was a disaster in February 2011). Finally the judge decided he can do nothing. I myself can try to see my child according to the UK registered Maltese order. He also decided that there will be another court hearing where court has to investigate if they can take over the case because my child is permanently in UK since more than one year. Or, if UK can return my child to Malta.

When I tried to see my child between 25th and 30th April 2013 the, through legal aid funded, solicitors from the mother requested from the Cafcass childs guardian to get a court order not allowing me to take my child with me.

I came to the school of my child on both days (25th and 26th April 2013 16:00) to see - originally I had planned to pick up - my child. But I have not seen him.

The last time I have seen my child alone was on 24th May 2009. On 19th June 2009 my child has been taken to UK.

When I had received bills of around 15.000 Pound from my UK solicitors in 2010 I had to stop with legal proceedings. I couldn't afford the horrible expensive and inefficient UK legal system.

Also In 2010 I had contacted you, the EU commission without success.

Now I am contacting you again and request reopen and to look at the case. The situation is different as I have a legal valid document registered in UK which should give me a 5 days visitation right and joint custody. Because I cannot solicitors in UK I am representing myself with a McKenzie Friend at UK court

I have the following questions (in reference to Brussels IIa):

- since when should the UK registered Maltese order should have been enforced ?
- why does the mother get legal aid to go against a valid court order ?
- why does the father does not get legal aid to implement the order ?
- was it allowed for UK court to defer the registered order in September 2012
- was it allowed to delay the implementation of the order in December 2012 when the father explicitly requested to implement the order
- was it allowed for UK court not to allow contact (especially in December 2012 when the father explicitly again asked UK court) ?
- is the in July 2012 UK nominated Cafcass Guardian allowed to deny psychological intervention from a psychologist as all have seen the bad condition of the child on 15th August 2012. The father requested this from court already in a position statement on 6th June 2012. The Cafcass Guardian does not have a qualified education on this
- the UK legal authorities have not given the Name and Address of the child's doctor to the father. Is this allowed ?
- there was very little information from the school to the father (on 25th April 2013 there was a visit now).
- is the Cafcass Guardian in the position to decide that the mother and father should go to a psychologist as there is no indication that the father suffers from a psychological sickness ?
- was the Cafcass Guardian - who has nearly for sure never seen the child alone - in a position to tell the father that he can see his child only for one hour on 6th September and 22nd October 2012 and then always in the presence of the mother ?
- was the Guardian in the position to stop all contacts from then saying we have to wait for a answer if UK gets jurisdiction ?
- was there a further alienation of the child when the Cafcass Guardian several times said 'I will never forceably remove a child from the mother' (the only she could have maybe said: 'I will never remove a mother from a child but even this is questionable)
- is UK court in the position to take over jurisdiction (when the Maltese Court say they should not get jurisdiction) ?
- in case UK court would get jurisdiction can they remove the order of joint custody and 5 days visitation right ?
- is UK court allowed to return my child to Malta
- is UK court allowed to make a decision against the father not allowing him to pick up his child (as requested and done on 24th April 2013)
- is the UK court allowed not to enforce the Maltese order from 28th December 2011 saying the father has to go through committal proceedings before.
- can I get/request financial compensation from UK for the bad behavior and denied support from UK court and UK authorities in the years 2009, 2010, 2011 2012 and 2013 (maybe thats the only way they learn to improve their system) ?
- where can I complain in UK/at EU level that the Maltese order is immediately implemented and that I get immediate contact with my child
- can you request further information from UK authorities or make an official complaint about the UK authorities ?
- can I get financial support or a legal assistance for the upcoming 2 1/2 day UK court hearing from the EU ?

If you need further information/documents let me know. Don't inform UK authorities about the papers I have sent to you as I am nearly for sure not allowed to send them.
