Dear Daniel [REDACTED],

Further to my email at the end of July and particularly with regards to CARS 21, let me inform you about some progress on our side.

First, I would like to confirm you the interest of ANFAC to be involved, representing the Spanish automotive industry, in any activities for the continuity of the CARS 21 initiative towards 2020. I think it's a great opportunity to contribute from our national perspective to the design of a sector strategic vision.

In this sense, we remain at your disposal and look forward receiving indications of any further steps on our side.

On the other hand, we are already working on a document linking the basic approach of Cars 21 final report and the main competitiveness factors of our industry in Spain, designing a scenario that allows us to return to production levels of 2007. We aim at identifying the pillars that enable us to manufacture again 3 million vehicles in Spain.

On this approach we will work in the coming months with the Government and other relevant stakeholders and will aim to link it with the presentation of Cars 21 report in Spain, as discussed in our meeting in July.
