Thank you for your participation in the recent **BUSINESSEUROPE** meetings to discuss the European Commission's Better Regulation agenda. We greatly appreciated the opportunity to discuss the new package with you and understand how it is to be implemented.

Consumer goods products should be appropriately and proportionately regulated.

JTI is a leading international tobacco product manufacturer. Today, our company has over 27,000 employees and operations in 120 countries worldwide. Our presence in Europe began when the company was founded after Japan Tobacco Inc. acquired the non-US operations of RJ Reynolds in 1999 and the UK-based tobacco manufacturer Gallaher in 2007. Specifically, our footprint in the European Union (EU) includes:

When the principles are followed, regulation is targeted and effective in achieving the policy objective it has set as a goal. It also means consideration is given to alternatives to regulation that could achieve these objectives.


We welcome the prioritization given by the European Commission to enhance a Better Regulation agenda through the entire policy cycle of
