Subject: Your application for access to documents – Ref GestDem No 2016/2563

We refer to your e-mail dated 3 May 2016, in which you make a request for access to documents, registered on 10 May 2016 under the above mentioned reference number.

We regret to inform you that no documents were found that would correspond to the description given in your application.

The European Structural and Investment Funds (ESI Funds) are managed under the "shared management" mode. This means that the Commission does not intervene in the "commitment" of individual projects, as you mentioned in your request, as this is done by the Member States. The management of the ESI Funds is entrusted to national bodies; the Member States' administrations (at national, regional and local level) choose which projects to finance and take responsibility for day-to-day management.

Major projects receiving more than EUR 50 million in support through the ESI Funds, are subject to an assessment and a specific decision by the Commission. However, also with respect to these projects the Commission does not hold a document as per your request.

Indeed, as specified in Article 2(3) of Regulation (EC) No 1049/2001, the right of access as defined in that regulation applies only to existing documents in the possession of the institution.

Given that no such documents have been identified, the Commission is not in a position to respond positively to your request.

In accordance with Article 7(2) of Regulation 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretary-General of the Commission at the following address:
