Having regard to **Delegation Agreement N° EAC-2015-0118**, (« the Agreement ») and **Amendment N° EAC-2015-0118/001** concluded between the Commission and the National Agency,

Whereas the NA has requested the Commission to modify the above Agreement and Amendment.

HAVE AGREED



1. The Agreement is amended as follows:

1.1 Article I.3.3.1 is replaced by the following

I.3.3.1 Funds for grant support from Heading 1 of the EU budget

The maximum amount of funds for grant support from Heading 1 of the EU budget is [REDACTED] hereafter referred to as "Erasmus+ Heading 1 funds".

The Erasmus+ Heading 1 funds set out in the first paragraph are further allocated to Key Actions and activities in the fields of education, training and youth as set out in the table below:
