Dear Mr Commissioner,

On behalf of myself and the European Fund for the Development of Polish Villages - Counterpart Fund Foundation (EFRWP) I have the honor to invite you, Mr Commissioner, to take part in the conference "Micro-sources of renewable energy as the basis of prosumer energy system, and prospects for their development in Poland and the EU", which will be held on June 25, 2016, at the Centre for International Cooperation in Grodno n/ Miedzyzdroje (Poland).

Until recently, the topic of prosumer energy did not exist in the public awareness in Poland, mainly because of excessive bureaucracy and the tax burden towards this sector. It will be a continuation and development of works on renewable energy that have been undertaken already within the framework of the Programme Council of the Foundation – i.e., the think-tank bringing together researchers from different disciplines and academic centers in Poland, which prepares reports, analyzes, and propose solutions to the key socio-economic problems associated with the development of Polish and European rural areas. We are confident that this conference can contribute significantly to increasing the interest of the current government circles in creation of appropriate legislative solutions in the field of renewable energy sources, already in operation in several EU countries (e.g., Germany - 1000 Roofs Programme).

We would also like to emphasize that all the environmental circles involved in the subject of renewable energy sources will participate in the conference – the government representatives, non-governmental institutions and social initiatives.

I would like to mention that the participation in the conference has already been confirmed by Mr Franz Fischler, former Commissioner for Agriculture and Rural Development, as well as Mr
