Dear Peter,

I was asked by my Minister to get in contact with you regarding the visit of Commissioner Hogan to Slovenia. They met at the margins

of the OECD meeting in Paris last week and they agreed that we shall get in touch to check the different options. Commissioner Hogan proposed that visit should take place some time in summer.

In this context our minister Mr [REDACTED] is proposing the following dates for the visit: between 7-10 June or between 14-17 June. He would very much like to host the Commissioner for 2 days to have enough time to present the specifics and challenges of Slovene agricultural sector.

Initial thoughts/proposals of my minister regarding the program of the visit are:

- the guiding topic during the visit would be agricultural production in less favourite areas, especially with regard to milk production with the visit to the Dairy and some dairy farms,
- he would also organise the meeting with Slovenian Agricultural Council to exchange the views on current situation as well as future prospects for agricultural sector,
- additionally we would present you some cases of diversification of activities (p.e. agri tourism) and visit to wine producers in the area.

Of course we are open to your suggestions with regard to the program of the visit as well as to the timing of the visit.

Please also indicate responsible person for the organisational aspects of the visit .

I really hope that we can realise the visit to the mutual satisfaction.
