We refer to your e-mail dated 26/09/2016, our reference Ares(2016)5572401, in which you make a request for access to documents, registered on the same day under the above mentioned reference number. We also refer to our holding reply of 14/10/2016 with reference Ares(2016)5938082 concerning the extension of the deadline.

You request access to documents relating to "all exchanges between the Commissioner Kroes, her office and her Cabinet, with the companies Uber and / or Salesforce from 1 January 2012 to 31 October 2014. Specifically, I would like to request any emails, correspondence, meeting notes or telephone call notes."

This request concerns a former Commissioner, so we had to consult the central archives service to search and provide us with the related registered documents.

The applicable legislation in this field is Regulation (EC) No 45/2001 of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data1.

When access is requested to documents containing personal data, Regulation (EC) No 45/2001 becomes fully applicable2.

According to Article 8(b) of this Regulation, personal data shall only be transferred to recipients if they establish the necessity of having the data transferred to them and if there is no reason to assume that the legitimate rights of the persons concerned might be prejudiced.

We consider that, with the information available, the necessity of disclosing the aforementioned personal data to you has not been established and/or that it cannot be assumed that such disclosure would not prejudice the legitimate rights of the persons concerned. Therefore, we are disclosing the documents requested expunged from this personal data.

In case you would disagree with the assessment that the expunged data are personal data which can only be disclosed if such disclosure is legitimate under the rules of personal data protection, you are entitled, in accordance with Article 7(2) of Regulation 1049/2001, to make a confirmatory application requesting the Commission to review this position.
