AWARD DECISION

Grant award procedure:

Proposals under the Asylum, Migration and Integration Fund Emergency Assistance (Application ref. no: HOME/2016/AMIF/AG/EMAS/0041, HOME/2016/AMIF/AG/EMAS/0042)

HAVING REGARD to Articles 128 (1) and 133 (2) of Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union (hereafter referred to as “the Financial Regulation”), and in particular,

HAVING REGARD to Articles 190 (1) and 204 (5) of Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of the Financial Regulation (hereafter referred to as “the Rules of Application”),

HAVING REGARD to Regulation (EU) No 514/2014 laying down general provisions on the Asylum, Migration and Integration Fund and on the instrument for financial support for police cooperation, preventing and combating crime, and crisis management,

HAVING REGARD to Regulation (EU) No 516/2014 establishing the Asylum, Migration and Integration Fund,

HAVING REGARD to Commission Implementing Decision C/2015/9534 of 15 December 2015 adopting the Work Programme and the financing for Emergency assistance in the framework of the Asylum, Migration and Integration Fund (AMIF) for the year 2016 for the budget line 18 03 01 01 – Asylum, Migration and Integration Fund – Strengthening and developing the Common European Asylum System and enhancing solidarity and responsibility sharing between the Member States, as amended by Commission Implementing Decision C/2016/1568 of 10 March 2016,

Whereas:


1. Grants for emergency assistance may be awarded under Article 21 of Regulation (EU) No 516/2014 to support Member States in a situation resulting from:
 - i. heavy migratory pressure in one or more Member States characterised by a large and disproportionate inflow of third-country nationals, which places significant and

- urgent demands on their reception and detention facilities, asylum systems and procedures;
- ii. the implementation of temporary protection mechanisms within the meaning of Directive 2001/55/EC; or
 - iii. heavy migratory pressure in third countries where refugees are stranded due to events such as political developments or conflicts.;
2. Grants for emergency assistance may be awarded without a call for proposals as specified in Commission Implementing Decision C/2015/9534 as amended by Commission Implementing Decision C/2016/1568, following a request for funding submitted to the Commission;
 3. An evaluation committee was appointed pursuant to Article 204 (1) of the Rules of Application in order to evaluate the project proposal submitted and issue a recommendation to the Authorising Officer;
 4. An evaluation was carried out pursuant to Articles 133 (1) and (2) of the Financial Regulation and 204 (1) of the Rules of Application;

I HEREBY DECIDE:

1. To award a maximum amount of EUR 76,380,928.00 for grants to the applicants listed in Annex 1.
