ADDENDUM 1 TO CONTRACT Phare/2003/064-754

The European Community ("the Community"), represented by the Commission of the European Communities ("the Commission") of the one part

And

Associazione Amici dei Bambini, with its office at via G. Frassi 19, 20077 Melegnano (Milan), Italy, ("The Beneficiary") of the other part

have agreed as follows:

The following provisions of contract Phare 2003/064-754, "Orphan Children, from institutional care to family-based care. The development of fostering and adoption for the right of the child to grow in family upbringing. An international comparison between Western and Eastern Europe" concluded between the Contracting Authority and the Beneficiary on 24th September 2003 are hereby replaced as follows

Article 2 - Duration of execution

2(2) The Operation's duration of execution, as laid down in annex I, is 12 months.

All other terms and conditions of the Contract remain unchanged. This addendum shall enter into force on the date on which it is signed by the later of the two parties.
