However, as you certainly know, your appointment has triggered widespread concern, both at EU, Member States, and citizens level, including from the European Ombudsman and from Members of the European Parliament.

Subject: Appointment of former President Barroso at Goldman Sachs

Dear Colleagur

You have recently been appointed as members of the Ad Hoc Ethical Committee.

As a rule, the Ad Hoc Ethical Committee is consulted on activities notified by former Commissioners related to their portfolio during the 18-month period foreseen in the Code of Conduct for Commissioners. This 18-month period is in line with the best existing standards for public office holders at European Union level. Former President Barroso's appointment at Goldman Sachs twenty months after his term of office was therefore not to be notified to the Commission.

However, in spite of the fact that the 18-month notification period has already expired, President Juncker has decided to exceptionally seek the advice of the Ad Hoc Ethical Committee in this specific case which concerns a former President of the Commission. You are certainly aware that this issue has received much attention from the public.

I would therefore ask you to provide President Juncker with your opinion on the respect of the principles of integrity and discretion as referred to in article 245(2) of the Treaty on the Functioning of the European Union, on the basis of the information provided by Mr Barroso in a letter addressed to President Juncker. This letter constitutes a response to a letter in which I, on the President's behalf, requested Mr Barroso to clarify the scope of his responsibilities.

For your information, you will find enclosed not only the two letters referred to above, but also President Juncker's exchange of letters with the European Ombudsman.

Please do not hesitate to contact me should you need any further information.
