(2) Dimitar Stoyanov was appointed rapporteur for opinion for the Union programme to support specific activities in the field of financial reporting and auditing for the period of 2014-2020.

(3) Klaus-Heiner Lehne was appointed rapporteur for opinion for the proposal for a Directive on approximation of the laws, regulations and administrative provisions of the Member States concerning the manufacture, presentation and sale of tobacco and related products.

2. A draft oral question on the further practical simplification of cross-border successions will be circulated for comments and approval by a written procedure. The question whether a resolution should be adopted is deferred until the committee has held a small hearing, to which the committee's former rapporteur on successions, Kurt Lechner will be invited.

3. Approval is to be sought for the holding of a mini-hearing on adoptions in April or May 2013.

4. Authorisation will be sought for non-legislative initiative reports:

- on Subsidiarity and Proportionality (19th report on Better Lawmaking covering the year 2011) (COM(2012)0373) and on the report on EU Regulatory Fitness (COM(2012)0746);
- on the 29th Annual Report on Monitoring the Application of EU Law (2011); (COM(2012)0714).

5. The secretariat is to sound out the secretariats of IMCO, CULT and ITRE in order to propose a way of proceeding with respect to the "Communication on content in the Digital Single Market". Once it is established which committee will take the lead, the others can apply to proceed with a Rule 50 procedure.

6. A hearing on the Common European Sales Law is to be held at the March 2013 meeting.

7. A hearing concerning the proposal for a directive on collective rights management is to be held on 18 March 2013 from 15.00 to 17.30.

8. A date is to be fixed for a meeting with members of the panel set up under Article 255 TFEU.

9. The Chair is to draft a letter setting out the conditions on which JURI could agree to the drafting of an own-initiative report by COBU on staff training in the European Commission.

10. A joint workshop by the FEMM and JURI Committees is to be held on the proposal for a Directive of the European Parliament and of the Council on improving the gender balance among non-executive directors of companies listed on stock exchanges and related measures for 19/20 March (procedure under Rule 51 with FEMM Committee).

11. The secretariat together with the Legal Service is to draft administrative guidelines on litigation for submission to the coordinators at the next meeting for their approval.

12. József Szájer is to set up a project team for his initiative report on delegated acts.

13. The secretariat is to put forward final proposals for the committee delegation to China as soon as possible. The possibility of concentrating the delegation on Shanghai is to be explored.

14. The secretariat is to report to the coordinators on progress with the proposed international convention on copyright and the visually impaired.
