

Therefore, failure to sign the agreement before 31 December 2009 will terminate

If the grant agreement is not signed by the person whose name appears in the grant agreement as the designated, legally authorised representative for signature, please inform the Commission immediately, communicating the full name and quality of the person authorised to represent your organisation for the purpose of signature of the present grant agreement.

- In the event of any alteration or modification made to the text of the grant agreement or its annexes, these should be regarded as null and void and the Commission will no longer be bound by the terms of the aforementioned grant agreement.

Please also note that:

- Article I.11.1 of the attached agreement contains a declaration of the co-ordinator that he/she has received the required mandates of the co-beneficiaries. Annex III to the agreement contains a template of such mandates conferring powers of attorney from the co-beneficiaries to the co-ordinator. These documents must be signed by each of the co-beneficiaries and yourself and returned with the signed grant agreement. Once the Commission is in possession of all signed documents, the pre-financing payment can be made.

You will, in due course, be informed about the kick-off meeting in Brussels which is planned to take place early in 2010.
