Dear all,

As you know, DG ENV and DG GROW intend to organise in May a meeting to discuss with relevant stakeholders about changes to be made in the "use descriptors" of the ECHA database (for the new version "IUCLID 6" to become operational in 2016) so as to improve and facilitate the search of information on substances registered under REACH that can be used for hydraulic fracturing purposes.

The meeting is expected to gather representatives from the oil and gas industry (IOGP), from the chemicals industry (CEFIC and EOSCA), from the civil society and from the European Commission (DG ENV and GROW). ECHA would join over the phone or in person depending on the date.
