I would like to request a meeting with you to discuss about a project that the European Services Forum has in mind.

We are thinking of organising a Conference on Trade in Services, with the objective to draw more attention of the fact that it represent more than 60% of EU exports in value added, and that trade in services negotiations have an impact much beyond services, since commitments on mode 1 (cross-border transactions), mode 3 (commercial presence abroad – FDI/investment) and mode 4 (temporary mobility of natural persons in the framework of a trade transaction) cover the whole economy, including increasingly the manufacturing world.

Before going ahead with the idea, I would be interested in exchanging views with you, since we would like to invite Commissioner Malmström as the keynote speaker. The intention would be to hold such a conference in the second semester of this year, under the Estonian Presidency. We are also thinking of inviting Mr. Sven Mikser, Minister of Foreign Affairs of Estonia, as well as WTO DG Azevedo.

Should you be interested to discuss of that matter, may I kindly suggest a meeting somewhere mid-April, after the Easter break?
