Dear Mister Broeckaert, many thanks for your follow up.

It is my understanding that the DINP dossier has now been submitted with all the correct files and that ECHA is going through the accordance check that could take up to 8 weeks (which means job would be completed early August if it is starting now).

Could you please confirm that the Public Consultation will start as of September and not before? The accordance check duration of 8 weeks is indicative and is often extended (e.g. in case the dossier is huge/complex etc.). If the dossier is not in accordance with CLP Requirements, it is impossible for us to estimate the date for the Public Consultation since the CLH dossier will be sent back to the dossier submitter for revisions and resubmission without legal deadlines. However, please note that if the CLH dossier is in accordance with the CLP requirements, the <u>legal</u> deadline of 18-month for RAC to issue an opinion will start at the date of the first submission. In that case, we have to process the CLH dossier without delay. In my view, it is unlikely that the Public Consultation will be launched during the summer. We can keep you informed as soon as a date for the public consultation is fixed (i.e. 2-3 weeks before the launch of the public consultation).

Is it possible to have access to the dossier before the Public Consultation starts? There is no possibility for you to get access to the dossier before the Public Consultation.

Do we already know the RAC rapporteur? Yes the Rapporteurs are known but their names are not disclosed before RAC discussion/adoption.

The CLH dossier has not been submitted to ECHA (in contrast to the expected date of submission of 01/03/2015 in the Registry of Intention). According to a recent communication from the Dossier Submitter (DS), it will be submitted in June. If you wish to receive more precision, please contact the DS at the e-mail address provided in the Registry of Intention (available <a href="here">here</a> for DINP).

After submission, the CLH dossier will be subject to an "accordance check" which ensures that the dossier meets the requirements for a harmonised classification and labelling proposal referred to in Art. 37 of the CLP Regulation and as specified in parts 1 and 2 of Annex VI. The "accordance check" usually takes a couple of weeks. If the CLH dossier is in accordance, the public consultation will be launched in September or October. If the CLH dossier is not in accordance, a revision of the CLH dossier will be requested to the DS. In that case, the launch date of the public consultation is unknown.
