Dear Ambassador, verelu Hen Massari!

I would like to thank you for your letter of 24 July 2017 concerning the launch of the procedure to appoint Mr Giovanni Kessler, currently Director-General of OLAF, as the new Director of the Customs Agency of the Italian Republic.

I understand that this is a key role, also in view of Article 33 of the Treaty on the Functioning of the European Union which highlights the importance of strengthening customs cooperation between Member States and the Commission. In this context the appointment of Mr Kessler would notably reinforce the exchange of best practices and contribute to a better mutual understanding between the Commission and the Italian Customs Agency. I would therefore be willing to make a recommendation to the College for a decision to facilitate this appointment.

However, I am bound to recall the independence OLAF enjoys in the discharge of its duties and of the importance of the function of Director-General of the Office to the European Parliament and to the Council, which are both explicitly mentioned in Regulation (EU, Euratom) 883/2013. For that reason it is necessary that, once Mr Kessler has confirmed that he wants to voluntarily step down as Director-General of OLAF, the Commission informs the other Institutions, as well as the OLAF Supervisory Committee, before proceeding to any decision.

As a result, I regret that I will not be in a position to recommend a decision to the Commission within a timeframe which matches the appointment date indicated in your letter. I would anticipate being able to revert to you on this matter in the autumn.

## Dear Alexander,

I am writing you concerning the situation of DG Giovanni Kessler. As you know, the Italian Government has appointed Mr. Kessler as the new Director-General of the Italian Customs Agency on the 28th July.

I have written, in advance of the formal appointment, to Commissioner Oettinger asking him to initiate the procedures within the Commission, so that Mr. Kessler could take up his new duties at the earliest.

At the same time, Mr. Kessler has been in contact with DG HR in order to agree on how to proceed. As you know, he intends to apply for a secondment in the interests of the service (art. 38 of the Staff Regulations), which must be approved by the College.

Commissioner Oettinger was kind enough to send me an immediate reply informing me of his support to Kessler's application and reminding me of the need to start a interistitutional consultation process, given the special nature of his current position (DG OLAF), which I fully understand.

This was before the summer break. Now, my authorities in Rome have indicated that they wish to have Mr. Kessler back to Rome on October 1st at the latest. The Italian Customs Agency has been headed by an acting Director-General since mid-August and the Government would like to have a fully empowered DG very soon.

I am therefore contacting you to ask for your support in putting Mr. Kessler secondment on the agenda of the College at the earliest possible moment (which, I understand, would be at he meeting scheduled for 20 September), so that he could take office on 1 October. A prompt decision by the Commission would be highly appreciated by my Government. Rome is convinced, and I personally share this view, that having a Commission senior official at the helm of a Member State agency which applies EU law and defends the EU financial interests on a daily basis would be an asset both for the Cpmmission and for the Member State concerned, in this case Italy. It would also be in both parties' interest that such an appointment could take effect as soon as possible.

# NOTE FOR THE ATTENTION OF MR GÜNTHER H. OETTINGER, COMMISSIONER FOR BUDGET AND HUMAN RESOURCES

Dear Mr Oettinger, Sehr Geerhter Herr. Commissan,

Thank you for the letter of 18 September 2017, Ares(2017)4636449, concerning the resignation of the OLAF Director-General, Mr Giovanni Kessler.

The OLAF Supervisory Committee is of the opinion that an interim replacement for Mr. Kessler should be appointed as soon as possible.

It is inappropriate for OLAF to be involved in any arrangements regarding Mr. Kessler's employment as Director of the Custom Service in Italy. His departure from OLAF must be final. Any entitlements to a posting at the level of Director-General, secondment payments or other arrangements between the Commission and the Custom Service in Italy must not involve OLAF, given its role in respect of customs.

Given the powers and sensitivity of the function of the OLAF Director-General, areas of potential conflict of interest with Mr Kessler's new function should be thoroughly examined and only then the Commission can consider granting its agreement, under the necessary conditions, to his taking up the new post.

# Subject: Resignation of Mr Giovanni Kessler as Director-General of OLAF

Dear Commissioner Oettinger,

By letter of 18 September 2017 you notified Mr Kessler's request to accept an appointment as Director of the Customs Agency of the Italian Republic. At the same time, you informed me of your intention to propose to the College of Commissioners to relieve the OLAF Director-General of his current function and to transfer him to a different function in the Commission.

In reply to your request to comment on this matter before 29 September, I would like to state the following observations:

First of all, it appeared in the press, that Mr Kessler was already appointed as head of the Italian Customs and Monopoly Agency at the end of July¹. I would therefore ask you to inform us that Mr. Kessler has not been appointed yet to another function at a time when he is supposed to carry out his duties as Director General and EU civil servant.

Secondly, if Mr. Kessler intends to take up a new function, the Commission would have to verify if a conflict of interest might arise and if a cooling-off period would need to be respected.

Thirdly, and from a budgetary control aspect, allow me to state my surprise that you consider a transfer to another function within the Commission. If Mr. Kessler intends to take up a professional activity at national level, it would seem appropriate that he either resigns if he wishes to leave the service of the institution definitively or that he asks to take unpaid leave on personal grounds. I fail to see how a transfer to another function in the Commission could be indicated if Mr Kessler wishes to take up a function at national level.

Finally, given the fact that the OLAF Director General is appointed after consultation with the European Parliament and the Council (Article 17(2)), I feel that Parliament and Council should also be consulted before the Commission nominates a temporary replacement of the outgoing OLAF Director General, while we are awaiting the completion of the ongoing recruitment procedure.

I am looking forward to receiving your further explanations in this matter!

in order to assist a national agency which collects customs duties on behalf of the EU budget and which has to operate effectively and cooperate with the European Anti-Fraud Office (OLAF);

- decided to agree to Mr Giovanni KESSLER's request and to:
  - i) create a temporary post of adviser hors classe in DG Budget;
  - ii) transfer in the interest of the service, under Article 7 of the Staff Regulations, Mr Giovanni KESSLER to this new temporary post of adviser hors classe, which would be abolished after his departure;
  - iii) second Mr Giovanni KESSLER, in the interest of the service, under Article 37(a) of the Staff Regulations, for a period of three years, to the Italian Customs and Monopolies Agency.

These decisions would take effect on 16 October 2017.

9. REPORT FROM THE COMMISSION TO THE EUROPEAN PARLIAMENT AND THE COUNCIL ON THE SINGLE SUPERVISORY MECHANISM ESTABLISHED PURSUANT TO REGULATION (EU) 1024/2013 (COM(2017) 591 AND /2; SWD(2017) 336; RCC(2017) 128)

Mr DOMBROVSKIS presented the Communication on completing the Banking Union and the report on the Single Supervisory Mechanism, which were submitted for the Commission's approval that day.

As an introduction he explained that there was broad agreement that a stable Economic and Monetary Union needed a complete Banking Union. However, the co-legislators had not made any real progress with the proposals presented by the Commission over the last two years. For that reason he felt it was the Commission's responsibility, given the institutional timetable, to launch a political appeal to the European Parliament and to the Council inviting them to speed up the process, otherwise the Banking Union could remain incomplete for several years.

The documents presented that day introduced significant new elements that would help the Commission to achieve its objective of completing the Banking Union before the end of its mandate. He pointed out that two pillars of the Banking Union were already operational and were working well, the Single Supervisory Mechanism and the Single Resolution Mechanism, thanks to which the EU's banking sector was now safer and more resilient.

Among the new elements in the Communication, Mr DOMBROVSKIS mentioned in particular its call for a common backstop for the Single Resolution Fund, which

could act as a final safety net once private debtors had borne the losses. He highlighted the broad consensus that had been established on this point at the Eurogroup meeting on 9 October and indicated that the set of proposals the Commission would present in December on the Economic and Monetary Union would give details of this mechanism.

He also mentioned the proposal concerning the European Deposit Insurance Scheme – EDIS – that the Commission had presented in November 2015 with the aim of protecting deposits regardless of the location of the banks. He noted that progress since then had been very slow. He explained that this legislative proposal remained on the table and that its objective remained unchanged, but that the Commission had considered it appropriate to make suggestions to the co-legislators in order to facilitate the adoption of this scheme by the European Parliament and the Council before the end of the current mandate. To this end, he placed particular emphasis on the proposal presented to the College for a progressive approach to both the reinsurance phase and the coinsurance phase as well as the introduction of an asset quality review to be carried out between these two phases in order to avoid the risks incurred at the banks concerned prior to the coinsurance phase.

Mr DOMBROVSKIS also mentioned the work currently being carried out in the framework of the Action Plan on retail financial services presented by the Commission in March, with the aim of enabling consumers and businesses in the European Union to benefit fully from a genuine single market for financial services. He added that the Commission was currently working on a proposal to reduce charges on cross-border banking transactions in accordance with the action plan for non-performing loans introduced by the Council in July. Lastly he pointed out the need to effectively communicate the tangible advantages of financial integration to citizens.

He closed by highlighting the positive assessment in the report on the Single Supervisory Mechanism.

During the brief exchange of views which ensued, the Commission raised the following main points:

- the importance of finding the right balance between reducing and sharing the risks in order to achieve a broad consensus among the Member States;
- at the same time, the belief that the discussion points presented by the Commission that day, which introduced a more progressive approach, particularly as regards the European Deposit Insurance Scheme, while at the same time strengthening the clarity and effectiveness of the future instruments of the Banking Union, would bring with them a positive dynamic that could speed up the process of adoption of legislative proposals by the co-legislators;
- the desirability of addressing the question of sovereign bonds and their risk level in order to help reduce the dependence between States and banks.

The PRESIDENT thanked Mr DOMBROVSKIS for his excellent work and closed the discussion by highlighting the importance of finalising the Banking Union in order to achieve a deeper and fairer Economic and Monetary Union. He noted the agreement of the Members of the Commission on the documents presented at the meeting.

Following this presentation and the discussion that ensued, the Commission:

- approved the Communication in COM(2017) 592/3 for transmission to Parliament, the Council, the European Central Bank, the European Economic and Social Committee and the Committee of the Regions, and, for information, to the national parliaments;
- approved the report in COM(2017) 591/2 for transmission to Parliament and the Council and, for information, to the European Central Bank, the European Economic and Social Committee, the Committee of the Regions and the national parliaments, together with the staff working document distributed as SWD(2017) 336, the contents of which were noted.

Thank you for your letter.

Let me first reassure you that Mr Kessler will continue to fulfil his duties as Director-General of OLAF until 16 October 2017. The Italian Council of Ministers' decision of 2 October to appoint Mr Kessler as Director of the Customs and Monopoly Agency will take effect after the College decisions to relieve him of his current function and to second him in the interest of the service from a Hors Classe Adviser function in DG Budget to the Agency.

Mr Kessler was appointed as an official to the function of Director-General of DG OLAF in 2010 following consultation of the European Parliament and the Council, and took up his mandate on 14 February 2011. This implies that at the end of his mandate of seven years, he remains in active service as an official. The Commission is, therefore, obliged to reassign him to another function in the Commission at his current grade when he ceases to be Director-General of OLAF

With regard to your concern of a possible conflict of interest, I should state that until he is relieved of his duties as Director-General of OLAF on 16 October 2017, he continues to carry them out in full independence. Moreover, I also see no conflict of interest between his current function and the function to which he will be seconded. On the contrary, it is clearly in the interest of the Commission to second an experienced Commission official to an important national agency like the Italian Customs and Monopoly Agency.

In its communications with the Commission concerning Mr Kessler's appointment to the Customs and Monopoly Agency, the Italian government has confirmed that they will cover his salary at the Agency during the secondment. This secondment will therefore also lead to savings, and it was in the budgetary interest of the Union to consider whether this would be a cost-effective option in comparison to reassigning Mr Kessler to other tasks within the Commission. The fact that the post in the Customs and Monopoly Agency carries a salary formed part of the Commission's decision.
