



I hope this email finds you well!

Please find enclosed a revised draft of Chapter 2. As you will see, with the help of Thomas and Claudia, I have made quite a lot changes which hopefully has improved the paper. Please let me know what you think!

I have a few questions/suggestions:

- What would you say are the main objectives of this chapter? I think we need a short paragraph on page 1 with aims and chapter outline
- Public expenditures are interesting and good arguments are provided for why policy makers should pay more attention to data collection and analyses. What I miss however, are some paragraphs explaining how pubic expenditures fit into the broader picture of policy evaluation approaches like cost-benefit analyses or cost-of-illness analyses. Do you think this should be included in chapter 1 or in chapter 2 and would any of you be happy to write these paragraphs?
- Is the wording of the definition on page 1 correct? ("The general government sector is composed by all resident institutional units that are other non-market producers whose output is intended for individual and collective consumption (at the central, state, regional, local and by the social security funds) in order to perform its functions")
- Is the statement on page 5 correct? ("Reuter (2006) proposes an alternative definition for public expenditure on drug control polices, based on the concept that any expenditure financing enforcement programs either reduce the demand for drugs by raising the transaction costs of buying drugs or lower the supply of drugs by making trafficking and production more difficult and risky. This classification does not have associated any systematic data collection exercise realized at an international level»).
- The last recommendation on page 12 doesn't really belong here, do you think? ("To measure the cost of unintended consequences of drug control policies in monetary units an approach is needed that is coherent with calculating the cost of illicit drug use. In this respect the international guidelines that were produced for estimating the costs of substance abuse based on the COI studies should be used as a starting point to develop an analogous methodology».)
- I have removed the text about the Canadian COI estimate as this is not particularly relevant in this chapter. Agree?
- I suggest to delete Appendix 3 too, do you agree?
- Are the steps described under "Methodologies for estimation" taken from another publication or developed here? I think this works well.
- I think the national examples of drug-related expenditures (Belgium, France, USA etc.) would be improved if we could be more specific on drug control expenditures and present actual, or relative, figures. Could you please add that?
- The references need to be sorted out

I don't know how you will organize the work within your group. Claudia has contributed a lot already and she will be travelling to Australia (!) soon. Could you Fatima take the lead and organize the work please? In order to give the other experts time to carefully read the text before the Reykjavik meeting I need to have your revised draft by Tuesday 19 May. Please let me know if this seems possible.

Deadline to presenting our final comments and contributions is coming soon, and so far I have struggled with a text on page 3 of Chapter 1 and comments submitted by Torbjorn.

I think that the phrase "The conventions do not oblige any penalty to be imposed for consumption per se[FT1] .[FT2] ", is far too simplistic, and therefore went to check a legal opinion that was submitted within the report of the Expert Group appointed by the Portuguese Prime Minister in February 1998.

This legal opinion is by a law teacher from the Coimbra University, and was the basis for the change operated in the Portuguese law which decriminalized drug consumption and subjected it to an administrative sanction:

(...) As for drug consumption, however, the nature of (the United Nations Drug) conventional standards seems to us diverse: in addition to a purpose assumed to be crucial — the treatment of drug and psychotropic substances users — Parties are left open the possibility of alternative, not only to a criminal sanction, as well as (an administrative) condemnation. What can only be understood in the light that drug consumption has not been typified as a type of crime (by the Conventions) - being therefore outside the scope of the criminal right - or, in a second case, in light of a framework guided by the procedural principle of opportunity. For above all, paragraph 2 Art. 3 of the Convention against Illicit Traffic in Narcotic Drugs, relating to consumption, states that the criminalization may be waived if conflicting with the constitutional principles

and the basic concepts of the legal domestic (national) system - unlike, as trafficking, there is no Subject to the obligation of sanctioning by criminal law. However, in addition to the criminalizing imperatives have seemed undesirable to the legislator constitutional, one of the fundamental concepts of our (Portuguese) criminal law is the principle of subsidiarity or *ultima ratio* of its intervention. All of these elements indicate therefore towards consideration of consumption drugs as an undesirable phenomenon that the State is fighting. The use of criminal law, however, appears only as one of the possible options of the ordinary legislator."

At issue is essentially paragraph 2 of Article 3 of the United Nations Convention of 1988, which states that, "Subject to the constitutional principles and the basic concepts of its legal system, the Parties shall take the necessary measures to establish as criminal offenses under its domestic law, when committed intentionally, the possession, purchase or cultivation of drugs or psychotropic substances for personal consumption contrary to the provisions in Convention of 1961 as amended and the 1971 Convention."

So my proposal is to rephrase the text to the following:

"The Conventions do not impose (or oblige) that countries impose a criminal sanction for consumption per se."



Social reintegration of drug users in treatment for instance is a demand side initiatives, right? If so, I will add that to the definition.

In the last paragraph however, I meant that if more drug users are caught by the authorities, there is an increased risk for unintended consequences like stigmatization etc. I'll try to make that more clear.

I have written this text for internal EMCDDA purposes with a short description of how do I see it. I wonder if this may be on any help to you.

This project makes a concise description of the 'state-of-the-Art' of the knowledge available concerning public expenditure on supply reduction initiatives. It describes main concepts, exemplifies good practices on estimation methods and presents the main data published by official entities. Further, it briefly refers to their limitations. The final aim of this publication is twofold. First, to contribute for increasing international awareness about the importance of this field of analysis. Second, to raise public awareness of the need to further invest increasing availability, comparability and reliability of data and estimates.

This project has been led by Anne Line Bretteville-Jensen and prepared by the Pompidou Group's expert group on 'Effects and associated costs of supply reduction'. 
