I have changed to footnote of Annex 3.

The number of observations reports the number of data records existing, taking into account the territory; countries and years available. The ratio compares the number of effectively reported observations with the total number of records, if no data were missing. Example: Europe (44) = 28/368: in Table 4, the conviction statistics of the European Sourcebook of crime and criminal justice statistics reports 28 data records, for the community sanctions imposed to drug offences in 2010, compared to the 368 data records that would exist if no data were missing, in the region Europe (with 44 countries).

Is it clearer, now?

If yes, if you understood, could you clarify the concept in the body of text, please? Otherwise, I think it is better we speak by phone and arrive to an agreement.

Concerning Paul Griffiths, I think that it could be better to finalize and prepare the paper for publication, before giving it to him or other colleague he tells us in EMCDDA. They would like to see the last possible version, ready to go to the printer. PG has so little time that it would be good if receives the latest possible version only. Otherwise we may miss 'the' opportunity...

The number of observations reports the number of data records existing, taking into account the territory; countries and years available. The ratio compares the number of effectively reported observations with the total number of records, if no data were missing. Example: Europe (44) = 28/368: in Table 4, the conviction statistics of the European Sourcebook of crime and criminal justice statistics reports 28 data records, for the community sanctions imposed to drug offences in 2010, compared to the 368 data records that would exist if no data were missing, in the region Europe (with 44 countries).

Hopefully, there are now less repetitions...I have however some questions to chapter 2. I know we have discussed some of them previously but I still have problems in understanding parts of the text. Could you please take a look and respond to my remarks/questions in the attached version of Chapter 2? I would be most grateful! If it is easier for you, we could talk on the phone.

I also would like to ask about the supply reduction term again. Peter Reuter states in one of his papers the difference between law enforcement of control policy and supply reduction initiatives and claim that the latter is only one part of law enforcement. I know the EMCDDA uses "demand and supply reduction" terminology but could you have a look to see if much would go wrong if we used drug control policy instead of supply reduction policy? For instance under 2.2 where we define the concepts; I suggest we swop "public expenditure on supply reduction initiatives" by "public expenditure on drug control initiatives". It would then be clear that we include public expenditure on law enforcement towards drug use and possession too (as many of the studies we cite do in their estimations). Would that be ok with you?

Sorry for bringing these topics up again but I feel that we are not fully consistent...

Overall, on chapter 3, I sometimes feel that subjects that have already been referred are done so again and again, like NSP, for example, without much added value.

Chapter 2 seems to be more robust in the sense of coherency, maybe because it was ready earlier and there was more time to go through it.

What I mean, is that it seems to me that there is some redundancy in Chapter 3, but I don't know how to solve that.

I will send you my comments on Chapter 4 until the 21st

First of all let me join Fatima and Fivos in congratulating you, Anne Line, on a great job. I think this document is a great improvement both in content and in clerity, and seeing all the chapters together makes a nice flow of coherency. I agree with Fatima that Chapter 4 provides a great comprehensive summary that reflects on the document as a whole.

Continuing Fatima and Fivos comments, chapter 3 has been the main focus of this report and of our repeated discussions, and it went through several revisions. I think it has improves significantly and Anne Line and others did a great job with it. However, I feel it is still somewhat confusing. The tables related to health effects include some social consequences that should appear in the later "non-health effects" tables, resulting in some repetitions or incoherency.

Dear Thomas and Anne Line,

It was a great pleasure meeting you in Oslo. Following our discussions after our meeting regarding the literature review I have attached a preliminary strategy plan. As we have agreed, the literature will be dichotomized into two main areas: the advocacy / policy review and the empirical studies. Of course there are going to be fluctuations and overlapping, but for a matter of clarity and organization I think it will be helpful to disentangle these two areas as distinct.

Therefore, the focus of my research at this point, taking into consideration the time frame, is to finalize the strategy plan, seek approval from the group, review the literature on the policy/advocacy area (key words such as prohibition, drug control measures, war on drugs etc.); and research available databases that provide information about identified harms (unintended consequences) of the current repressive drug control regime. These may include incarceration rates from crimes related to drugs (possession; trafficking); pre-detention rates due to minor drug related offences; quality of life of drug user in prison (treatment availability; conditions; etc); recidivism and relapse rates following prison release, etc. These databases may include governmental reports; correctional facility reports; EUROSTAT; EC reports: European Sourcebook of Crime and Criminal Justice Statistics and other European and International reports.

As you may see in the attached draft strategy I took the initiative and went one step further, by suggesting at least at this preliminary stage the phases, extraction procedures etc. Of course these issues are going to be discussed and hopefully agreed by the group, but for now i believe it's good to have some kind of guideline showing where we are going and how to get there. Please have a look and I hope you can take some time to give me your opinion. Shall I wait some kind of written agreement, and do you need any additional information from me? Please let me know.

Once again it was a great pleasure meeting you and I hope for a constructive and fruitful collaboration.

Thank you so much for your literature review strategy — a really professional and comprehensive draft! I see that the suggested strategy is in line with how a formal literature review *should* be done. My worry is that this is too ambiguous given the time frame and the role the review is meant to have in our report. As I see it, the aim of the review is to give us an overview of the state of art that can serve as a useful starting point for the report itself. It would have been very good with a more comprehensive review but I don't think that is feasible right now, nor a task for the expert group. Pavel Bém mentioned that the group behind The Global Drug Report already have conducted a review along the lines we have in mind, so hopefully, this could be a "flying start" for our review. Have you been in contact with him after the Oslo meeting? He said he would be happy to pass on their review.

Cláudia Storti suggested that some of the four weeks we agreed on should be spent on searching databases like the EuroStat one to get information on what data that actually exist that could be relevant for us. I think she's right. It will be most useful to get a better knowledge of what kind of databases and variables that are there to analyze and compare public expenditure etc. How to split the four weeks on these two very different tasks I don't know but perhaps you and Cláudia could discuss it? I cc her in this email.

I hope my response will not discourage you. Your work will really be helpful for writing the report and for getting a better understanding of what existing data sources can contribute to our end. Don't hesitate to contact me if you have any questions.

Reminding that; The three major international drug control treaties are mutually supportive and complementary. An important purpose of the first two treaties is to codify internationally applicable control measures in order to ensure the availability of narcotic drugs and psychotropic substances for medical and scientific purposes, and to prevent their diversion into illicit channels.
