Following the call for proposals of 26th April 2017 concerning projects of common interest under the Connecting Europe Facility in the field of energy, on 25th January 2018 the CEF Coordination Committee gave a positive opinion on a list of Actions proposed for funding.

Overall comments

The action is part of the cluster 3.8. Bulgaria –Romania [currently known as "Black sea Corridor"]. The proposal will contribute to the reinforcement of the Romania transmission system, better connecting the Black Sea area.

The action will contribute to an increase of cross-border transfer capacity between Romania and Bulgaria.

Overall, the proposal would have significantly benefitted from more quantification, more substantiation and other supporting documentation to justify or substantiate the evaluation criteria defined in the Regulation (EU) 1316/2013.

The proposal elaborates on positive externalities such as macro-regional security of supply (SoS), including market integration by reinforcing transmission infrastructure. However, no accurate information with regards to SoS and market integration was provided in the proposal.

The proposal demonstrates poorly how (e.g, most obvious) Bulgaria is positively affected by the action in a quantified way.

The need to overcome financial obstacles is demonstrated in a good manner, yet the stimulating effect of the Union's financing could have been better demonstrated.

The proposal is of high political priority, the action is embedded in a cluster of projects with significant positive impact for the region, and the project will contribute to reaching the 10% interconnectivity target for Romania and Bulgaria.

The proposal is recommended for funding.
