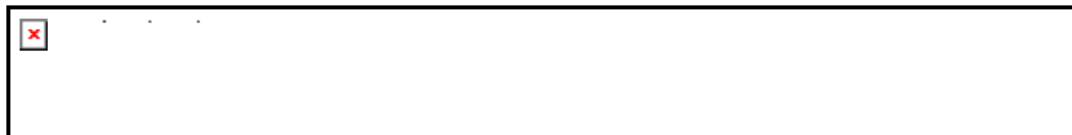

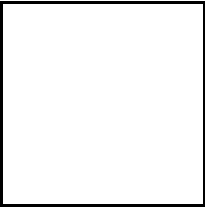
Dear both,
