Subject: Your access to documents request under Regulation 1049/2001

Dear Ms Marti,

I refer to your e-mail dated 05/01/2019 in which you make a request for access to documents, registered under the above-mentioned reference number.

After careful assessment of your request, I would like to inform you that the first two points in your request do not fall under Regulation 1049/2001 for access to documents, as they are requests of information publicly available. With regards to these, you will find below some information which I trust you will find useful.

Concerning your first point on the number of homeless people in the EU, the main challenge when it comes to collecting data and statistics in the field of homelessness and housing exclusion is the lack of a single definition of the phenomenon accepted in all the EU member states.

At the 2010 European Consensus Conference, stakeholders and the European Commission agreed on the ETHOS¹ definition, which refers to four living circumstances as homelessness or extreme forms of housing exclusion². However, the methodologies for counting the number of people who are homeless or experiencing one or several of the living circumstances described by ETHOS differ between member states and there exists no common indicator at EU level.

The European Commission supports through its funding programme for Employment and Social Innovation (EaSI)³ the work of the European network of associations working with the homeless, FEANTSA, which includes the provision of estimates of the number of homeless in member states, published in their annual housing exclusion overview⁴ in collaboration with the Fondation Abbé Pierre. Although the figures are not comparable country by country, due to the different methodologies for counting the homeless, they allow monitoring the evolution of the issue in member states over time. With regards to your second question on public policies carried out at EU level to combat homelessness, I would like to recall that, in accordance with the Treaties on which the European Union is based, the primary responsibility for tackling homelessness and housing exclusion lies with member states at national, regional or local authorities' level depending on the internal distribution of competences. The European Union has however a key role to complement and support the efforts of member states in this field, namely through policy guidance and orientation and funding opportunities.

Homelessness and housing exclusion are addressed in the 2013 staff working document "Confronting homelessness in the EU"⁵, which was part of the Social Investment package⁶. In addition, the recently proclaimed European Pillar of Social Rights⁷ recognised the importance of housing and assistance for the homeless as a key social principle⁸.

On this basis, the Commission gives policy guidance and monitoring under the European Semester, an annual process which enables the EU member countries to coordinate their economic policies throughout the year and address the economic challenges facing the EU. In recent years there has been an increased coverage of social policy concerns in general and housing-related issues in particular in the European Semester country reports and country-specific recommendations.⁹

The European Commission also supports the member states through facilitating mutual learning in the area of social protection and through support from the EU Funds, such as the European Regional Development Fund, the European Social Fund and the European Fund for Strategic Investment. These funds are used to support housing solutions and the development of accompanying services in order to improve the housing outcomes of people in a situation of homelessness, or at risk of housing exclusion.
