- all correspondence, including attachments (i.e. any emails, correspondence or telephone call notes) between this agency (including the Director and the Cabinet) and Facebook or any intermediaries representing its interests; and
- all documents prepared for the purpose of the meeting and/or exchanged during the course of the meeting."

As for any request for documents, your request of 07 March 2019 has been registered by the Agency on 04 April 2019¹ as an initial application for access to documents under Regulation (EC) No 1049/2001² and the Agency's Steering Committee Decision³.

Please note that this is a private third-party website, which has no link with any institution of the European Union, hence, the Executive Agency cannot be held accountable for any technical issues or problems linked to the use of this system.

In reply to your initial request for access to documents, we regret to inform you that the Executive Agency does not hold any documents that would correspond to the description given in your application.

Please note that during the abovementioned period the Agency did not hold any lobby meetings with Facebook or its intermediaries. For this reason, the information requested is not included in any existing document.

As specified in Article 2(3) of Regulation (EC) No 1049/2001, the right of access as defined in that regulation applies only to existing documents in the possession of the institution.
