Subject: Invitation to the Inter-Service meeting on criteria for identification of Endocrine Disruptors, the review of the existing Community Strategy for Endocrine Disruptors and the new strategy for Endocrine Disruptors

In 1999 the Community Strategy for Endocrine Disruptors addressed for the first time the problem of endocrine disruption in the EU. Fourteen years later it is time to review the Union Strategy and reflect on its achievements, taking stock of the significant developments in the science base for endocrine disruptors. Importantly, in the last couple of years legal obligations were introduced to identify scientific criteria for the identification of endocrine disruptors in several pieces of legislation.


DG ENV started in 2010 through consultation of stakeholders to discuss potential scientific criteria and to consider the review of the Community Strategy. Currently also political pressure is rising, e.g. in 2012 the Council and in 2013 the European Parliament called for more action in the area of endocrine disruption by the Commission. The Parliament specifically called for horizontal criteria for defining endocrine disruptors, from which a number of pieces of legislation would benefit, providing certainty to the internal market on what constitutes an endocrine disruptor.

We have been consulting with you over the last months on various issues and aspects related to our work on endocrines, and a package of 3 documents was prepared to address the legal requirements to develop scientific criteria for identification of endocrine disruptors, and to take account of the significant progress in science and changes in legislative framework. We would very much appreciate your input on these draft documents with a view to launch the Inter-service Consultation on these documents before the summer break.

Therefore I would like to invite your services to an Inter-Service meeting at unit level for a detailed presentation and discussion of the draft Commission Recommendation defining criteria for the identification of endocrine disruptors, the draft Commission Staff Working Document reviewing the current Community Strategy for Endocrine Disruptors and the draft Commission Communication for a new Endocrine Disruptor Strategy.

I would therefore appreciate receiving your nominations for this meeting (by email to Katinka.van-der-jagt@ec.europa.eu), preferably by the 28th of May. The meeting is foreseen for 5 June, and will take place at our premises in Beaulieu starting at 9:30 – 12:30 in meeting room 0A. The draft agenda for the meeting is enclosed and the draft documents will be sent to the attendants one week before the meeting.
