Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Kazakhstan by revealing the substance of concerns with regard to market access problems in Kazakhstan expressed by some MS, which could have an impact on EU's relations with Kazakhstan and undermine its position when tackling the issue.

- Page 3, point 4.2, nineteen words of the third sentence on that page have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Ukraine by revealing the substance of the concerns with regard to a market access problems in Ukraine expressed by several EU Member States.

- Page 3, point 4.2, tenth and eleventh sentences have been withheld

Page 3 and page 4, point 5.1, thirteen sentences have been withheld

Disclosure of this information could undermine the EU's position when dealing with Argentina and when tackling the issue.

- Page 5, point 5.3, one sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information and the assessment regarding the political strategy to be adopted and the possible steps envisaged with regard to Brazil's Good Manufacturing Practices Certification, which could have an impact on EU's relations with Brazil and undermine its position when tackling the issue.

- Page 5, point 6.1, one sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding EU's tactical approach and possible future actions towards a measure taken by the US. Disclosure of this information could undermine the EU's position when dealing with the US and when tackling the issue.

- Page 5, point 7, nine words have been withheld

Art. 4.1 (a) third indent of Regulation 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information concerning the EU's tactical approach as regards EU market access policy in China.

- Page 6, point 8, one sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding EU's assessment of a measure taken by Egypt. Disclosure of this information could undermine the EU's position when dealing with Egypt and when tackling the issue.

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards import restrictions in Argentina, which could have an impact on EU's relations with this country and undermine its position when tackling the issue.

- Page 2, point 3.3, two sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards Vietnam's electromagnetic compatibility testing, which could have an impact on EU's relations with this country and undermine its position when tackling the issue.

Art. 4.1 (a) third indent of Regulation 1049/2001 - risk of undermining the protection of international relations of the EU with Korea by revealing the concerns expressed by one Member State on EU market access issue in Korea, as well as its opinion on the tactical approach, which could have an impact on EU's and Member State's relations with South Korea and undermine its position when tackling the issue.

- Page 3, last paragraph under point 5.2, first sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the EU's political strategy to be adopted and the next steps envisaged with regard to a market access issue in South Korea, which could have an impact on EU's relations with South Korea and undermine its position when tackling the issue.

- Page 3, last paragraph under point 5.2, third sentence has been withheld

- Page 6, point 10, three words in the second sentence and one word in the sixth sentence have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by disclosing the identity of a third country with which the EU has discussed market access issues in China, which could have an impact on EU's relations with that third country and China and undermine its position when tackling the issues.

- Page 7, point 11, twenty-one word and 4 sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding a particular issue that has been under discussions in the EU-Canada CETA negotiations, as the texts have not been yet finalised.

#### **(4) MAAC of 29 May 2012**

- Page 2, second paragraph of point 4.1, four sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Argentina by revealing the substance of the concerns of a Member State with regard to a market access problem in Argentina, as well as its proposal for a political strategy to be adopted by the EU.

- Page 2, third paragraph of point 4.1, one word been withheld

Art. 4.2 first indent of Regulation No 1049/2001 - risk of undermining the protection of commercial interests of a natural or legal person: revealing the name of the company which is mentioned in the context of the market access case in Argentina discussed in the meeting could undermine the position of the company concerned on the Argentinian market.

- Page 2, point 5.1, eighth sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Brazil by revealing the opinion of a Member State with regard to a market access problem in Brazil and asking the EU to take action.

- Page 4, last paragraph of point 6, three sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the position and tactical approach with regard to market access issues in China, which could have an impact on EU's relations with the country and undermine its position when tackling the issue.

- Page 7, second paragraph of point 12, three words have been withheld

Art. 4.2 first indent of Regulation No 1049/2001 - risk of undermining the protection of commercial interests of a natural or legal person: revealing the name of the company which is mentioned in the context of the market access case in Turkey discussed in the meeting could undermine the position of the company concerned on the market in Turkey.

- Page 2, point 4.2, thirty words of forth sentence have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the political strategy to be adopted and the next steps envisaged with regard to a market access issue in Turkey, which could have an impact on EU's relations with Turkey and undermine its position when tackling the issue.

- Page 2, point 4.2, three last sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information with respect to a WTO dispute settlement which could undermine EU's position when dealing with the third country concerned.

- Page 3, point 5, fourth sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the political strategy to be adopted and the next steps envisaged with regard to a market access issue in Indonesia, which could have an impact on EU's relations with Indonesia and undermine its position when tackling the issue.

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding EU's assessment of measures taken by Indonesia as well as its tactical approach

and possible future actions towards it. Disclosure of this information could undermine the EU's position when dealing with the third country concerned and when tackling the issue.

- Page 5, point 8, first paragraph, last sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the political strategy to be adopted with regard to the issue related to international transport permits in Russia which could have an impact on EU's relations with Russia and undermine its position when tackling the issue.

**(6) MAAC of 19 July 2012**

- Page 2, third paragraph under point 3, four last sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards the specific aspect of the ongoing implementation of the EU-Korea FTA, which could have an impact on EU's relations with Korea and undermine its position when tackling the issue.

- Page 3, point 5.3, fourth and fifth sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing EU's assessment of the internal situation in Brazil, as it could lead to misleading interpretation of EU's bilateral relations.

- Page 3, first paragraph under point 5.4, last sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards the market access issue related to Russia's recycling fee for imported vehicles, which could have an impact on EU's relations with Russia and undermine its position when tackling the issue.

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards the negotiations for a Deep and Comprehensive Free Trade Area (DCFTA) between the EU and Morocco, which could have an impact on EU's relations with this country and undermine its position when tackling the issue.

#### **(7) MAAC of 24 September 2012**

- Page 1, point 1, seventh sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with China by revealing the identity of one EU Member State expressing concerns and the substance of the concerns with regard to a market access problems in China.

- Page 3, point 6.1, six sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the strategy to be adopted with respect to a WTO dispute settlement, which could have an impact on EU's relations with the third countries involved and undermine its position when tackling the issue in Argentina.

- Page 4, point 6.2, two sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing the name of a third country regarding the position with regard to market access concerns in Brazil, which could have an impact on EU's relations with the third country.

- Page 4, point 7.2, two sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the political strategy envisaged with regard to market access issues related to ECOWAS CET, which could have an impact on EU's relations with ECOWAS member countries and undermine its position when tackling the issue.

- Page 5, point 7.3, two sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Norway by revealing the concerns expressed by several EU Member States about the customs reclassification of the plant hortensia by Norway and requesting action from the EU with regard to this market access issue.

- Page 5, point 9, one sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding EU's assessment of a measure taken by Turkey. Disclosure of this information could undermine the EU's position when dealing with the third country concerned and when tackling the issue.

- Page 3, point 5, one sentence in the first paragraph

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding an EU action and the reaction by the Authorities of India towards market access problems in India, which could have an impact on EU's relations with the country and undermine its position when tackling the issue.

- Page 3, second paragraph under point 5, first sentence has been withheld

Art. 4.2 first indent of Regulation No 1049/2001 - risk of undermining the protection of commercial interests by revealing the name and concerns expressed by a business association with regard to a market access problem in India.

- Page 3, second paragraph under point 5, fourth sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with India by revealing the concerns

expressed by several EU Member States requesting action of the EU with regard to a market access problem in India.

- Page 3, second paragraph under point 5, seventh sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with India by revealing the opinion of one EU Member State with regard to a market access problem in India and asking the EU to take action.

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Norway, by revealing the request of several Member States, with regard to EU's political decisions in the context of market access problems in Norway.

- Page 3, point 3.4, one sentence has been withheld

Art. 4. 1 (a) third indent of Regulation 1049/2001 - risk of undermining the protection of international relations of the EU with India by revealing the opinion of a Member State since it could lead to a misleading interpretation of EU's bilateral relations.

- Page 3, point 3.5, fourth paragraph, fifth sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Brazil by revealing the opinion of one EU Member States expressing concerns with regard to NTBs in the automotive sector in Brazil and asking the Commission to take action.

- Page 5, point 6, first paragraph, fifth sentence has been withheld

- Page 5, point 6, first paragraph, seventh sentence has been withheld

Art. 4. 1 (a) third indent of Regulation 1049/2001 - risk of undermining the protection of international relations of the EU with Ukraine by revealing the opinion of a Member State since it could lead to a misleading interpretation of EU's bilateral relations.

#### **(10) MAAC of 13 December 2012**

- Page 2, point 2, last paragraph, names of officials have been withheld

Art. 4.1 (b) of Regulation No 1049/2001 - risk of undermining the privacy and integrity of the individual in particular in accordance with Community legislation regarding the protection of personal data by disclosing the names of the officials, not holding management positions, mentioned in the meeting. The names of the persons concerned have therefore been deleted.

- Page 2, point 3.1, last paragraph, second sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Indonesia by revealing the opinion expressed by several Member States with regard to the issue related to export restrictions on raw minerals and stones in Indonesia.

- Page 2, point 3.1, last paragraph, seven words in last sentence have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards the issue related to export restrictions on raw minerals and stones in Indonesia, which could have an impact on EU's relations with this country and undermine its position when tackling the issue.

- Page 5, point 8, one sentence in the first paragraph and twenty-six words in second paragraph have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing EU's assessment of measures taken by Ukraine. Disclosure of this information could undermine the EU's position when tackling the issue with Ukraine.

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations with Vietnam by revealing the opinion of some EU Member States regarding the ongoing EU-Vietnam FTA negotiations, which could have an impact on EU's relations with Vietnam and undermine its position when negotiating with Vietnam.

- Page 3, point 5.1, seven words in last sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards the issue related to export restrictions on raw minerals and stones in Indonesia, which could have an impact on EU's relations with this country and undermine its position when tackling the issue.

- Page 3, point 5.2, second paragraph, two sentences have been withheld

- Page 3, point 4.3, two sentences have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding EU's assessment of the measure taken by Russia related to the double guarantee requirement as well as possible future actions towards it. Disclosure of this information could undermine the EU's position when dealing with Russia and when tackling the issue.

- Page 3, point 5.1, one sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards Ecuador's import restrictive measures, which could have an impact on EU's relations with this country and undermine its position when tackling the issue.

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards the ongoing EU-Ukraine DCFTA negotiations, which could have an impact on EU's relations with the country and undermine its position when tackling the issue.

- Page 2, point 4.1, second paragraph, sixteen words have been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing the assessment of business with regard to Norway's customs duty increase on cheese and asking the Commission to take action, which could have an impact on EU's relations with Norway and undermine its position when tackling the issue.

expressed by several Member States with regard to the implementation of the EU-Korea FTA and requesting the Commission to take action, which would have an impact on EU's relations with Korea and undermine its position when tackling market access issues in Korea.

- Page 2, point 4, second paragraph, last sentence has been withheld

Art. 4. 1 (a) third indent of Regulation 1049/2001 - risk of undermining the protection of international relations of the EU with Korea by disclosing the sentence as it provides EU's comment regarding the EU-Korea FTA implementation.

- Page 3, point 5.1, one sentence has been withheld

Art. 4.1 (a) third indent of Regulation No 1049/2001 - risk of undermining the protection of international relations of the EU by revealing information regarding the tactical approach towards the ongoing EU-Japan FTA negotiations, which could have an impact on EU's relations with Japan and undermine its position when tackling the issue.
