

Summary:

A meeting between Commissioner Hogan and BusinessEurope took place upon the association's request on 13 December 2019. The discussion focussed on the following issues:

China: BusinessEurope expressed concerns with regard to level playing field, market access
issues and increasing trade distortions in China, notably in key manufacturing sectors. Will
present a comprehensive China paper in January covering these issues and possible tools to
address them and invited Commissioner Hogan to attend the launch of the report. They intend
to promote the paper widely including in the US in early 2020. Also voiced support for an
ambitious CAI.
