Subject: Meeting with Eurogas - my input

Et voici:

- Representatives from Eurogas started by conveyed their support to the long-term goals of the EU, and highlighted the importance of having gas acknowledged as part of the energy transition to climate neutrality goals. They also informed about exploratory work with biogas as future business opportunity
- CAB members conveyed the importance of the EU's Long-Term Strategy, as direction of travel for Europe and focused in particular on the need to have broad societal support to achieve those goals. They explained about some of the enabling and supportive measures launched by the Commission, e.g. Innovation Fund, Just Transition Fund, Batteries Alliance. They also pointed out that the Green Deal is a sustainable growth strategy for Europe's economy and Commission is therefore keen to hear from economic actors, how they expected to contribute to EU's neutrality goals. They highlighted the role of the CAP: EAFRD co-finances investments for on-farm biogas production; in addition, in the proposals for the future CAP, one of the nine specific objectives is the promotion of bioeconomy (which includes bioenergy), which will be an opportunity for the Member States to design interventions for biogas production. Innovation and research, including Horizon 2020 research programme, will also play a role.
