Access is also granted to minutes of a meeting with external parties. These documents were drawn up for internal use under the responsibility of the relevant service of the Cabinet Simson. It solely reflects the service's interpretation of the interventions made and does not set out any official position of the third parties to which the document refers, which was not consulted on its content. It does not reflect the position of the Commission and cannot be quoted as such.
