Subject: Your application for access to documents – GESTDEM 2020/2444

We refer to your e-mail of 17 April 2020 in which you make a request for access to documents under Regulation (EC) No 1049/2001 regarding public access to documents² as well as under Regulation (EC) No 1367/2006 on the application of the provisions of the Aarhus Convention³, registered on 24 April 2020 under the above-mentioned reference number.

You request access to "any documents on the issues related to Belarus nuclear power plant project in Astravyets (NPP Astravyets), its nuclear safety and security and its adverse environmental, economic and the security of energy supply effects as well as possible adverse impact on the stability of energy supply and transmission systems in the Union. (...)". The request also concerns any documents testifying the actions

requested from, initiated by and deployed through the Union bodies to mitigate those adverse effects. The request in particular concerns issues, linked to the Astravyets NPP project and related, *inter alia*, to the environmental protection – the Espoo Convention and the Aarhus Convention.

Please note that due to the wide scope of your request, covering also areas falling under the responsibility of other Directorates-General, parts of your request have been attributed to other Directorates-General⁴. This reply relates only to the documents held by Directorate-General for Environment. You received the replies from the other respective Directorates-General in due course.

The Commission was not able to identify any documents related to the Aarhus Convention that would fall under the scope of your application.

Some parts of these documents have been blanked out as their disclosure is prevented by releasing personal data. This is based on the exception outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001 and because these documents contain the following personal data:

- The names and initials and contact information of Commission staff members not pertaining to the senior management;
- The names/initials and contact details of other natural persons;
- Handwritten signatures/abbreviated signatures of natural persons.

Article 9(1)(b) of the Data Protection Regulation does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested documents, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

We would like to draw your attention to the fact that the documents registered under Ares (2017)3303144 and Ares (2019)2969717 originate from the Lithuanian authorities, and the documents registered under (Ares (2019)298719 and Ares (2019)592439 originate from the Belarusian authorities. They are disclosed to you based on Regulation (EC) No 1049/2001. The European Commission does not assume any responsibility from their reuse.

The disclosure of the remaining 5 documents (i.e. briefings) is prevented by the exception of the right of access laid down in Article 4(1)(a) third indent of Regulation (EC) No 1040/2001. According, to this provision "the institutions shall refuse access to a document where disclosure would undermine the protection of (a) the public interest as regards [...] international relations". The non-disclosed documents are related to the Ostrovets NPP compliance case, which is still open under the Espoo Convention. The

forthcoming Meeting of the Parties to the Espoo Convention (8-11 December 2020, Vilnius) will address this specific case in a follow-up decision. The disclosure of these documents, at this stage, would undermine the EU external representation and international relations.

Lastly, this disclosure is without prejudice to the rules on intellectual property, which may limit your right to reproduce or exploit the released documents without the agreement of the originator, who may hold an intellectual property right on them.

In accordance with Article 7(2) of Regulation (EC) No 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.

Such a confirmatory application should be addressed within 15 working days upon receipt of this letter to the Secretary-General of the Commission at the following address:
