Dear Mr Lasauskas,

Thank you for your request for access to documents, which the European External Action Service (EEAS) has examined in the framework of Regulation (EC) No 1049/2001.<sup>1</sup>

After a search in the EEAS filing systems, document management databases and archives, we have identified the documents referenced in Annex to this letter.

Following their examination, we are pleased to provide partial access to the **documents no 1-16, 20-22, 25-33, 35, 36, 43, 45-83.** Please note that they have been redacted in order to remove content that is out of the scope of your request, as well as personal data as per Article 4(1)(b) of the Regulation. Furthermore, redactions have been made in line with Article 4(1)(a), third indent, and Article 4(3) of the Regulation in order to remove information on diplomatic contacts and negotiating positions of the EU institutions. The disclosure of these parts would undermine EU's relations with Belarus and would adversely affect the EEAS decision-making process as regards the ongoing diplomatic negotiations on EU-Belarus Partnership Priorities. The disclosure to the public of such information would limit EEAS margin of manoeuvre and capacity of negotiation with Belarus.

In addition, please be informed that documents **no 60, 65** and **82** originate from the Lithuanian authorities, documents **no 78** and **80** from a Member of the European Parliament and document **no 83** from Belarusian authorities. We have obtained third parties' consent for disclosure, in line with Article 4(4) of the Regulation, and we are pleased to forward them in attachment to this letter.

I take this opportunity to remind you that the documents provided may not be copied or reproduced for commercial purposes without prior consultation with the EEAS.

As regards the remaining **documents no 17, 18, 19, 23, 24, 34, 37, 39, 40, 41, 42, 44,** I regret to inform you that we are not in a position to disclose them neither as a whole nor partially at this point in time. These are preparatory documents for the ongoing negotiations of EU-Belarus Partnership Priorities, containing internal assessments and other elements that are part of the process to formulate negotiation positions of participating stakeholders. The disclosure to the public of these documents would harm the possibility to maintain an environment of mutual trust and serenity during our negotiations with Belarus, diminish the EEAS's margin of manoeuver and thus hamper the decision-making process during the negotiations as per Article 4(3), first paragraph, of the Regulation. The breach of trust and the unilateral release of these documents would also undermine the EU's relations both with EU Member States and Belarus, as per Article 4(1)(a), third indent, of the Regulation. The EEAS considered whether there was an overriding public interest which would overcome the exception invoked under Article 4(3) of the Regulation, but we were not able to identify any such interest.

The EEAS regrets not to be in a position to release those documents, which are protected by the exceptions under Article 4 of the Regulation.
