Subject: Your application for access to documents - Ref. GestDem No 2013/5433

Dear Mr Cabo,

We refer to your e-mail dated 05/11/2013 in which you make a request for access to documents, registered on 08/11/2013 under the above mentioned reference number.

Your application concerns the following documents:

- Schedule of the trip, and names of the Eurostat officials travelling.
- Detailed agenda of the meetings with Spanish public bodies, and names of the public servants attending those meetings.
- Minutes of those meetings.
- Any report elaborated by the Eurostat delegation as the result of the trip.

Having examined the documents requested under the provisions of Regulation (EC) No 1049/2001 regarding public access to documents, I have come to the conclusion that they may be partially disclosed. For parts of the documents your application cannot be granted as their disclosure is prevented by exceptions to the right of access laid down in Article 4 of this Regulation. As for the document "schedule of the trip" no such document was specifically drawn up. The schedule of the trip was implicitly covered by the agenda.

The expunged parts of the documents which you seek to obtain relate to an on-going process initiated under Regulation (EC) No 479/2009¹ with a view to assessing the quality of statistical information provided by the Member State concerned, under that Regulation. The process is still at a preliminary stage and no decision has yet been taken by the Commission.

Disclosure of these documents would undermine the protection of several interests. Firstly, the purpose of the on-going process, as it would put in the public domain preliminary findings which have not yet been confirmed and which may be rebutted by the entities involved.

Therefore, the exception laid down in Article 4(2) third indent of Regulation 1049/2001 applies. Secondly, the decision-making process of the Commission, as it would reveal preliminary views and options which are currently under consideration. The Commission services must in this regard be free from external pressure. Therefore the exception laid down in Article 4(3) first subparagraph of Regulation 1049/2001 applies.

Thirdly, as regards your specific request for names of persons, the integrity of these individuals must be protected in accordance with Union legislation on the protection of personal data. Therefore the exception laid down in Article 4(2)(b) of Regulation 1049/2001 also applies. However, the Commission official heading the mission, Mr Luca Ascoli, Head of Eurostat's unit D.1, has given his explicit consent to his name being disclosed.

In addition to the document to which access is granted, we have considered whether partial access could be granted to other documents requested. However, we have found that those documents are entirely covered by the exceptions indicated above.

The exceptions laid down in Article 4(2) and 4(3) of Regulation 1049/2001 apply unless there is an overriding public interest in disclosure of the documents. You have in your application not provided information that would indicate that such overriding public interest would be at hand.

In accordance with Article 7(2) of Regulation 1049/2001, you are entitled to make a confirmatory application requesting the Commission to review this position.
