**Subject:** Your application for access to documents – GESTDEM 2021/8091

Dear Ms Cann,

We refer to your request for access to documents pursuant to Regulation (EC) No 1049/2001, which was registered on 14 December 2021 under the above-mentioned reference numbers.

You request access to the following:

- 1. A list of all lobby meetings (including phone calls, conference calls, video conferences etc.) held by DG JUST since 1 January 2021 where the Sustainable Corporate Governance Directive was discussed. The list should include the names of the individuals and organisations participating; the date; and any minutes / notes produced.
- 2. Additionally, any emails, policy papers, or other correspondence related to the Sustainable Corporate Governance Directive between DG JUST and lobbyists during this time period.

I consider your request to cover documents held up to the date of your initial application. The list of documents falling within the scope of your application is to be found in the annex.

With regard to the redacted documents, a complete disclosure is prevented by the exception concerning the protection of privacy and the integrity of the individual outlined in Article 4(1)(b) of Regulation (EC) No 1049/2001, because they contain the following personal data:

- the names/initials and contact information of Commission staff members not pertaining to the senior management;

- the names/initials and contact details of other natural persons;
- handwritten signatures/abbreviated signatures of natural persons.

Article 9(1)(b) of the Data Protection Regulation does not allow the transmission of these personal data, except if you prove that it is necessary to have the data transmitted to you for a specific purpose in the public interest and where there is no reason to assume that the legitimate interests of the data subject might be prejudiced. In your request, you do not express any particular interest to have access to these personal data nor do you put forward any arguments to establish the necessity to have the data transmitted for a specific purpose in the public interest.

Consequently, I conclude that, pursuant to Article 4(1)(b) of Regulation (EC) No 1049/2001, access cannot be granted to the personal data contained in the requested documents, as the need to obtain access thereto for a purpose in the public interest has not been substantiated and there is no reason to think that the legitimate interests of the individuals concerned would not be prejudiced by disclosure of the personal data concerned.

Please note that some parts of the following documents have also been redacted, as they do not fall within the scope of your request:

- Ares(2021)4266837: Report on virtual meeting with Better Finance on sustainable corporate governance and xx, 30 April 202;
- Ares(2021)4089637: Flash report on the meeting with the Confederation of German Employers Association BDA on the sustainable corporate governance initiative, 17 June 2021.

Please note that documents originating from third parties are disclosed to you based on Regulation (EC) No 1049/2001. However, this disclosure is without prejudice to the rules on intellectual property, which may limit your right to reproduce or exploit the released documents without the agreement of the originator, who may hold an intellectual property right on them. The European Commission does not assume any responsibility from their reuse.

As regards meeting minutes or summary records of meetings with external parties, these documents were drawn up for internal use under the responsibility of the relevant services of the Directorate-General for Justice and Consumers. They solely reflect the services' interpretation of the interventions made and do not set out any official position of the third parties to which the documents refer, which were not consulted on their content. They do not reflect the position of the Commission and cannot be quoted as such.

In case you would disagree with the position laid out in this letter, you are entitled, in accordance with Article 7(2) of Regulation (EC) No 1049/2001, to submit a confirmatory application requesting the Commission to review this position.
