Dear Mr Fanta,

We refer to your application for access to documents under Regulation (EC) No 1049/2001¹ regarding public access to European Parliament, Council and Commission documents, submitted via AsktheEU.org website. You requested access to the following documents: *"The final report, draft final report or any other summary report of the preliminary investigation by OLAF into a possible conflict of interest of Commissioner Johannes Hahn, as first reported by French daily Liberation on December 1st, 2021"*.

After having carried out the necessary verifications and consulted the relevant services within OLAF, we regret to inform you that OLAF does not hold any documents that would correspond to the description given in your application.

As specified in Article 2(3) of Regulation (EC) No 1049/2001, the right of access as defined in that regulation applies only to existing documents in the possession of the institution. However, OLAF holds no such documents, corresponding to the description given in your application. Therefore, OLAF is not in a position to fulfil your request.
