If you can please let me know if this would be possible and when then I would be most appreciative.

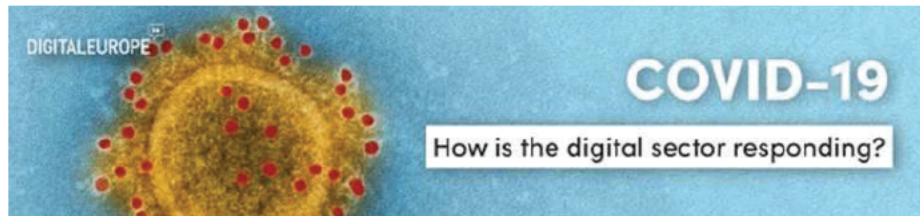

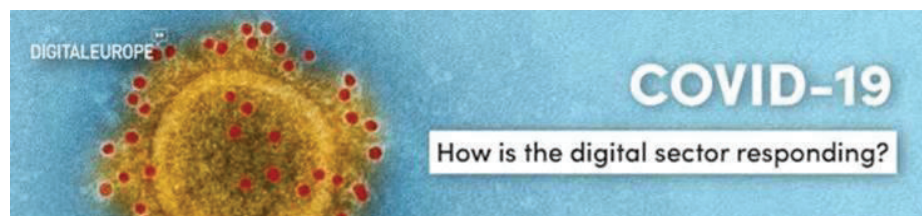
