Many thanks for your response.

It is unfortunate that [REDACTED] and Executive Vice-President Vestager **will not be able to meet at Web Summit in November**. As I said in my email, there are a number of issues which Executive Vice-President Vestager is working on which directly impact Deliveroo, as a platform working in six EU markets with over [REDACTED] self-employed riders. Deliveroo is committed to offering flexible work to those who choose to work in the on-demand economy, while also providing security, for example insurance and online learning opportunities.
